

“The Hadtobenuts Derby” Quarter Horse Derby

“\$11,500 ADDED!!!!”

2013 Rules and Conditions:

1. This Derby is open to all 3 year old registered quarter horses that have been tattooed, parentage verified, and the owners and trainers are properly licensed to run in the state of Idaho. This Race is sponsored by Dan and Connie Moon in conjunction with Idaracing and Hawthorne Animal Hospital. \$7,500 of the added money is provided by Dan and Connie Moon, owners of “**Hadtobenuts**”. “**Hadtobenuts**” stands at Hawthorne Animal Hospital, www.hawthorneanimal.com; 5011 Hawthorne Road, Chubbuck, ID 83202 (208-237-1149).
2. 85% of the nomination money will be added to the purse.
3. Eligible 3 year olds that were conceived by being bred by a Stallion that was standing @ Hawthorne Animal Hospital receive a \$150 discount on the final payment, and are considered “Hawthorne Horses”. Discount will not apply to any horse that late pays after July 1st.
4. Eligible 3 year olds that were born as a result of its dam being Artificially Inseminated @ Hawthorne Animal Hospital also can receive a \$150 discount on the final payment, and are considered “Hawthorne Horses”. Discount will not apply to late pays after July 1st.
5. Payments are either to be physically delivered or postmarked by the due date of the payment.
6. Late payment will be double the nomination/sustaining payments through July 1st. Any late payments after July 1st will be \$2,000; accepted until time of Entry.
7. The race will be conducted under the rules of the Idaho State Racing Commission.
8. Upon the unlikely event of a mechanical failure the process of selecting the finalists will be decided on a basis determined by the State Stewards.
9. Trial heats will not consist of more than ten horses. The finalists will be determined by the times of the fastest ten qualifiers from the trials. Dead Heats or ties that would exceed the 10 allowable horses in the final gate would be decided by drawing lots as directed by the State Stewards. In the event a horse is disqualified in the trials, the horse would be given the time of the horse it is placed behind plus 0.01 seconds.
10. If starting gate fails to open all payments will be refunded, less 15%.
11. All decisions of the track management and the Stewards are final.
12. Purse distribution for the Finals; 40%-20%-10%-8%-6%-5%-4%-3%-2%-2%
13. The track management, the Sponsor, and the State all reserve the right to cancel or postpone the trials and the finals for any reason they deem good and sufficient. Upon a cancellation 85% of payments would be refunded.
